AGENDA	DISCUSSION
Open Meeting	Quorum established. (16 of 17 members present).
Motion	Eric Day made a motion to approve the minutes for April 14, 2026. Brad Huerta spoke in support of the motion. Motion passed.
Motion	Eric Day made a motion to approve the May 12, 2026 agenda. Brad Huerta spoke in support of the motion. Motion passed.
Closed Meeting	A motion to go into Executive Session was made. Motion passed unanimously. Idaho Statute Title 74, Chapter 2, “(d) To consider records that are exempt from disclosure as provided in Chapter 1, Title 74, Idaho Code;”. During Executive Session, the Idaho TSE Council discussed two pending TSE applications that were recently surveyed and interviewed potential candidates for four governor-appointed seats. A motion to exit out of Executive Session was made. Motion passed unanimously.

TSE Regional Reports	North Region – Kirstin Haley Kirstin Haley shared the region will host mock multi casualty incident (MCI) exercises to identify patient care gaps, and as well providing EMS provider education classes. Lastly, reports are being provided on the mild traumatic brain injury (mTBI) data pertaining to the rural community areas. The next regional meeting will be on Thursday, July 23rd. North-Central Region – John Sieckowski John Sieckowski shared the region will host an Idaho TSE System education for EMS providers to earn free continuing education credits, and as well providing education using the TSE educational flyers on trauma, stroke, and STEMI at community events. The next regional meeting will be on Tuesday, May 19th. Southwest Region – Dr. Parker Fillmore Dr. Parker Fillmore shared at the last regional meeting, a thrombectomy case was presented that show the importance and effectiveness of an organized system of TSE care. As well, the Trauma, Stroke, and STEMI subcommittees are creating plans and goals for community education. The next regional meeting will be on Tuesday, June 18th. South-Central Region – Fran Jamison Fran Jamison shared the region is promoting BEFAST education every Friday for patients discharged from the hospital and implemented the new stroke guidelines' recommendations. As well, the region continues to conduct trauma triage drills. The next regional meeting will be on Wednesday, May 13th. Southeast Region – Joseph Higgins Joseph Higgins shared the committee discussed how critical access hospitals (CAH) have matured in advancing and improving TSE capabilities. The next regional meeting will be on Tuesday, June 16th. East Region – Eric Day Eric Day shared the region hosted Stop the Bleed™ community education classes and included education on stroke and STEMI signs/symptoms and EMS transport. As well, the region will be conducting MCI exercises for facilities. The next regional meeting will be on Thursday, May 21st.
TSE Branch Update	Melissa Ball shared 71 designations from 35 out of 45 facilities have been approved which makes up 78 percent of Idaho facilities who hold one or more TSE designation. The TSE Branch is working with the Governor's office to declare Idaho as a Stroke Smart state, hopefully signing a proclamation in June. The event will have speakers and supporters with educational posters, and the media will push a unified message. At the National Association of State EMS Officials (NASEMSO) annual conference, members discussed the need for states to integrate trauma systems with military operations related to Large-Scale Combat Operations (LSCO).

EMSC Program Update	Stacy Rodgers presented on the final creation of the Prehospital Readiness Recognition Program and stated it will roll out during EMS Appreciation Week on May 20 th . The National Pediatric Readiness Project (NPRP) assessment is a gap analysis report to determine areas of improvements and strengths are for hospital emergency departments. The assessment is open until May 31 st and occurs every 5 years. Lastly, the program will receive 500 new, updated Broselow Tapes and will distribute these to EMS agencies and hospitals statewide in June. Lastly, the EMSC Advisory Committee created a Pediatric Decision Tools Card to help hospital providers with decision making pertaining to pediatric diagnosis/treatment using tools such as calculators and algorithms.
Prehospital Blood Protocol	Jade Parsons, Division Chief of Training for Canyon County Paramedics (CCP), presented an overview of the Treasure Valley prehospital whole blood program, including its treatment approach, blood administration procedures, and essential resources and equipment. The program's protocols/policies and training are available to EMS agencies who are interested in developing their own agency program.
TSE Council Strategic Plan	The Idaho TSE Council determined two strategic goals that will be incorporated in the Statewide System of Care Plan: • Goal 1: Funding source for long-term sustainability of the Idaho TSE System • Goal 2: Increase community outreach and education including injury prevention on Trauma, Stroke, and STEMI
BRFSS Brain Injury Presentation	Jonas Frankel-Bricker, Health Data Analysis for the Division of Public Health, presented the utilization of the Behavioral Risk Factor Surveillance System (BRFSS) to develop methods and generate outcome data on mTBI.
Idaho TSE TBI Guidelines	The six TSE Regional Committees will identify which facilities have adopted the new guidelines and over the next year track whether BIG 1-3 patients are being kept or transferred to a higher level of care. This feedback will help to determine its effectiveness and if any changes need to be made.
2027 TSE Standards	Melissa Ball shared Trauma, Stroke, and STEMI workgroups are reviewing the proposed revisions of the 2027 TSE Standards and focusing on aligning criteria/language across all three TSE areas. As well, shared the proposed increase to the annual TSE designation and site surveys fees to support the long-term sustainability of the Idaho TSE System.
